Temple Ehmsen introduced a subject for discussion concerning the lack of representation of radio at the Federal level on the Civil Defense Board. This being shown by the number of telephone men on every board throughout the country in the State Civil Defense Councils. Numerous ones spoke briefly on this subject and a motion was introduced by Mr. Ehmsen and seconded by Captain Vernon that the Northwest Chapter go on record as requesting the National President to protest to Governor Millard Caldwell of inadequate representation of radio at a federal level on the Civil Defense Board.

Sgt. Barden of King County Sheriff Office advised the members should be notified of the APCO meeting in Seattle for the Gold Cup Races on August 8 and 9 and also concerning whether they want to register for the Virginia 5 at five dollars a head or on separate yachts. PROTEST FCC DELAY

A regular meeting of CPRA was held at Palm Springs, May 23, 1952.

Meeting was called to order by Charles Smith at 10:30 a.m. in the absence of both the President and Vice-President of the organization.

Financial report on joint meeting was read and approved.

A letter from the civil defense organization asking for permission to use Inter-City Net was read and permission granted conditionally. Conditions referred to were agreed upon previously at a special meeting of net users.

Bill McKinley made a motion to have

meetings start on time or a financial penalty be placed on the presiding officer. Motion failed to pass. Another motion amending the by-laws to require meetings to start within ten minutes of the stated time carried.

Bud Whiteman presented an extreme example of danger to public lands caused by five month long delay of the FCC to clear a frequency for fire use in his county. Various suggestions were made on what possible action could taken in this case, and others of a similar nature where a real urgency existed. No decision was reached on the matter, however.

A motion was made to have a committee prepare a resolution, which, in effect, would relax the requirements of announcing call signs of mobile units to a status of equality with other specified mobile services. Motion carried.

Committee was appointed consisting of Kenneth Corner, Bill Durham, and Ray Meyers.

Commercials were introduced and given a chance to plug their products.

Meeting was adjourned for lunch and the afternoon was spent sight-seeing around Palm Springs.
