The September meeting of the California Public-Safety Radio Association was held Friday, September 20, 1974 at the Mediterranean Restaurant in San Bernardino with 58 members and guests attending.

President **Don Griffin** opened the meeting at 10:00 A.M. with an expression of thanks to hosts **Don Henley** and **Jerry Campbell**, Department of Communications, County of San Bernardino. He then introduced the chapter officers and called for self-introductions of members and guests.

On a motion passed, the minutes of the July meeting were approved without reading. **Dave Crockett** gave his treasurer's report and stated that the chapter has 156 active and 33 commercial members.

After Al Botallico reported on FCC dockets, President Griffin commented on the EMS frequency and operational problems in the greater Southern California area and opened the floor to discussion. CPRA has received several letters in support of the chapter acting as frequency coordination group for EMS, especially the UHF region. Ed Messinger, Los Angeles County Communications, briefly discussed the recent meeting of personnel from several Southern California counties now using or contemplating bio-medical telemetry communications equipment. He pointed out the numerous problems associated with the operation of a bio-med system including helicopters. He suggested CPRA officially notify the FCC that it is willing to coordinate all frequency assignments in the EMS segment of the
